11. NEW MEXICO STATE UNIVERSITY PRESIDENT'S REPORT

President Couture introduced our community college presidents for the update on their campuses. The community colleges are extremely important to the NMSU system and play a key role in providing access to higher education across the state.

12. INFORMATIONAL PRESENTATIONS

a. NMSU – Álamogordo, President Cheri A. Jimeno

President Jimeno reported on the following:

- Enrollment declined .5% from last year
- Summer enrollment is up 12%
- Completion Agenda
 - o Quick Connect Want all faculty to get involved
 - Calling Campaign Check on student progress
 - Mandatory Orientation All students need to attend before being registered
 - Completion Wall (Phi Theta Kappa) To help with completion rates.
 Student's sign wall to keep in mind their educational goals.
 - Mid-Semester Check (dual credit) High School students in dual credit courses will know where they stand in mid semester.
 - Advising (degree plans)
 - o Optional versus Required. The choices will be decreased.
- Accreditation from the Higher Learning Commission (HLC) will be held on February 11, 12 & 13, 2013. Draft for the self student report will be out for review in August and needs to be in by November.
- Title V Grant
 - o Five year, \$3.2 million

- b. NMSU Carlsbad, President John Gratton

President Gratton reported on the following:

- Enrollment has declined from 2009 to present due to employers in the southeastern part of the state are employing high school graduates at a pretty good wage. Many from the gas industry are making \$60,000 – \$70,000 per year.
- Enrollment Results
 - Spring 2012 Headcount 2,762 (drop in dual credit)
 - Summer 2012 Headcount 787 (.4% increase) Semester Credit Hours 3,363 (5% decrease)
 - Fall 2012 Headcount 812 (26.5% increase) Semester Credit Hours
 5,260 (5.3% increase)
- Title V Grant
 - o Allied Health Initiatives
 - Health Information Technology program will begin Fall 2012
 - Surgical Technician program slated for start in Fall 2013
 - Planning will begin on a Physical Therapy Assistant Program (The requirement is that it needs to be directed by a Doctor of Physical Therapy)
 - Additional student success initiatives in Fall 2012 to meet with students who are struggling in the Allied Health field to receive tutoring and mentoring.
- Newly approved degree programs to start Fall 2012
 - o Agriculture Economics
 - o Hospitality and tourism
 - Health Information Technology
 - o Automotive Body Collision Repair
 - o Fire Science Technology
 - o Hazardous Materials
- Workforce Education Initiatives
 - Expectation of major donations from Intrepid Potash and Mosaic
 Potash want workers for the Mines (approximately \$700,000)

- Funds will be deposited in the NMSU Foundation and used for major equipment purchases
- o Mechanical and electrical specializations will be offered
- New degree application will be presented for an AAS and certificates in Industrial Maintenance Mechanic program of study
- o Interest expressed in a heavy equipment operator's certificate
- Industry representatives have volunteered to spearhead fund raising efforts

 - Parking lot and exterior lighting has been replaced
 - Classroom and hallway lighting has been replaced with energy efficient choices
 - Energy savings have been realized
 - Request for a rebate from Excel Energy has been submitted

 - NMSU Carlsbad was interested in pursuing a child care/child development center, but with federal requirements that are coming in regarding childcare, it may not a feasible financial decision. Will review again before making a final decision.
- HLC Accreditation
 - o NMSU Carlsbad will submit its AQIP report in November 2012
 - o HLC Check slated for Fall 2013
 - o Accreditation visit 2014-2015
 - NMSU Carlsbad faculty and staff have expressed interest in moving to the "Open Pathways" model and leaving AQIP.

c. NMSU – Dona Ana, President Margie Huerta

President Huerta reported on the following:

 - Dr. Margie Huerta has been Appointed to the Board of Trustees for the CollegeBoard from November 2012 – 2016 (nominated by Secretary Garcia)
 - DACC was ranked in the Top100 Associate Degree Producers Special Report – these are the institutions that have the most success in awarding associate degrees to minority students.
 - DACC is an Achieving the Dream Leader College Out of 1200 Community Colleges there are 40+ that are classified as Leader Colleges

President Casados reported on the following:

- Enrollment has been down 10.1%
- Invested in our Faculty and Staff by Implementing NMSU Mercer Salary Study
- Invested in Facilities approximately \$4,000,000 in 7 years. Two
 campus facilities were 1960 era Job corps buildings in a severe state of
 disrepair.
- \$500,00 State Severance Tax Bonds Funds available July 1, 2012
- \$1,000,000 State General Obligation (GO) Bond Pending voter approval November 2012 general election
- State Licensed Campus Child Development Center Infant to School Age Children. Run by a nonprofit organization and serves about 50 children. Will be utilizing the 2012 Severance Tax Funds to hire architects for preliminary planning/design for a new center with a goal to obtain estimated construction cost to secure funding for construction. Would like to eventually tie the center into the Education Program.
- Federal Grant Resources Secured
 - US Department of Education Title V Hispanic Service Institutions October 1, 2009 – September 30, 2014 at approximately \$574,549/year.

- US Department of Education Title V Hispanic Service Institutions
 Cooperative (w/UNM-Valencia as lead institution) October 1, 2011 –
 September 30, 2016 at approximately \$300,000/year.

13. RECURRING REPORTS

a. Report from the Chair, Faculty Senate by Dr. Stu Munson-McGee

Dr. McGee reported to the board that that after investigating the last election, there were problems getting the ballots out to community colleges and remote campuses. Faculty Senate will redo the election in the Fall semester to try to prevent disenfranchisement of those faculty members. In previous elections, they would see a 20% return on the ballots, but this last election there was only a 10% return. They will be working this summer to make sure this doesn't happen again.

- b. Report from the President, Associated Students of New Mexico State University by Ms. Breeana Sylvas
 - President Sylvas reported that she has hired directors to the different departments within ASNMSU. A calendar has also been created to list the different events that will be taking place in the Fall semester.
- c. Report from the Chair-elect, NMSU Employee Council by Dr. Fred Lillibridge

Dr. Lillibridge reported that Employee Council has been working on the ERB. They have a resolution asking the ERB Board, during this session, to come up with a plan to make this program solvent. They are also working with HR to make sure the university community gets an opportunity to weigh in with ERB to make their feelings known on how this program can be fixed.
