BUDGET

The legislature started at a quicker than usual pace to deal with a shortfall in funding for the fiscal year 2017 budget (current fiscal year which started July 1, 2016 and ends June 30, 2017). The December 2016 Revenue Estimate projected that ending reserve balances were at a -\$69.1 million, or -1.1% of recurring appropriations. The December report also projected that FY18 had a negative balance \$93 million, or 1.5 percent below FY17 appropriations.

The Governor took an unprecedented action by vetoing a total of \$766.1 million that includes all higher education institutions and the legislative branch. \$745 million of the line item veto included higher education institutions. The Office of Government Relations will prepare an additional report once the budget issues are resolved for FY18.

FY17 Solvency

In order to resolve the FY17 budget issue the legislature passed and the Governor signed three bills shown in the table below. The three bills ([HB4 – Revert Balances of Certain Funds](#); [SB 113 \(Reduce Appropriations and Transfer Funds\)](#); and [SB 114- School District Cash Balances](#)) as signed by the Governor, balanced FY17 and created a reserve of approximately 1.6%. The three bills do not have an impact on higher education or NMSU budgets.

FY18 Budget

The General Appropriations Bill for FY18 went through its final approval process (concurrence of the Senate amendments to HB2 by the House of Representatives) on March 17, 2017. On April 7, 2017 the [Governor line-item vetoed](#) the legislative branch and all funding for higher education institutions. The Governor vetoed HB 202 (Tax of a Business Without a Physical Presence) which provides additional revenues that is required to maintain a balance budget. More detail is provided below for both bills.

There are three actions to resolve the ongoing political situation with the budget: 1) The legislature has filed legal challenge regarding the Governor’s authority to line item veto an entire branch of government and constitutional entities such as NMSU; 2) the governor can call a special session and set the agenda on what will be debated; and 3) the legislature can call themselves into an extraordinary session and they will control the agenda. An extraordinary session requires the vote of 3/5 of the members elected.

The Legislative-passed HB2 reduces all of higher education by one percent for a total funding level of \$779.3 million for all higher education institutions and the Higher Education Department, a decrease of 5.9 percent when compared to the FY17 appropriated level or a decrease of 1.0%

when compared to the FY17 special session level. The higher education budget is 8.1% percent below the FY16 funding level.

The overall reduction for Instruction & General (I&G) in the legislatively passed bill is based on a 1% reduction in base funding and a 2% base redistribution through the funding formula instead of 4% as requested by the Executive and the Legislative Finance Committee.

Both the LFC and the Executive recommended to roll-up several Research and Public Service Projects into I&G, however the final legislative version of the bill does not include the roll-ups except that NMSU’s Clean Drinking Water Technology was combined with the Water Resources Research Institute.

HB2 as passed by the legislature provides a total of \$190.6 million for the NMSU system, a reduction of 1.1% from the FY17 special session funded or a reduction of 6.0% from the FY17 level. The Water Resources Research Institute received new non-recurring funding totaling \$1.0 million that continues the Governor’s water initiative, initially funded in 2013. Full details of the NMSU budget is located in the appendix.

FY18 Solvency

The final legislatively-approved HB2 requires an estimated \$156 million to balance and is included in [HB 202 \(Tax of Businesses Without A Physical Presence\)](#). Other measures also passed that will help with solvency, such as [HB 191 \(Oil and Gas School Tax to Stabilization Reserve\)](#), are included in the table on page 7.

HB 202 was modified significantly during the legislative process and includes the following: closes loopholes and allows for the collection of gross receipts on internet sales; increases the motor vehicle excise tax; adds a second part fee for weight distance tax application; reforms the health care tax; repeals the deduction of GRT on sales to nonprofit organizations; reduces the monthly distributions to the legislative retirement fund; increases the gasoline tax by 10 cents per gallon and provides a temporary distribution to the tax stabilization reserve and the state road maintenance fund once reserves hit 5 percent; increases the special fuels tax by 5 cents; and delays the five-year phased reduction of corporate income tax CIT enacted in 2013 by two years. The LFC estimates that this bill will generate new revenue as shown below.

* The estimates assume \$20 million for the internet sales section (a conservative midpoint), \$12.7 million for the corporate income tax (CIT) rate delay, and either \$0 or the full amount for the weight-distance tax permit fee (see individual impacts below and Fiscal Implications)

According to the Legislative Finance Committee Fiscal Impact Report, HB 191 as introduced, distributes revenues in excess of an annual five-year average for the oil and gas emergency school tax to the tax stabilization reserve. This bill was modified significantly, as it went through the Senate by incorporating parts of HB 412 (Representative Harper’s Tax Reform Bill). The Senate Finance Committee added language that repealed several deductions, exemptions and credits with delayed repeal dates and includes language for the Revenue Stabilization and Tax Policy to study the deductions and credits and report back to the legislature with recommendations in December 2018 and December 2020. The bill repeals textbooks exemption from GRT (7-9-13.4).

CAPITAL OUTLAY REAUTHORIZATION

NMSU requested two capital outlay reauthorizations for the NMSU Agricultural Research Center at Alcalde and NMSU-Carlsbad. Both requests were included in SB 362 and the bill was signed by the Governor.

HIGHER EDUCATION RELATED LEGISLATION

All legislation is germane during a 60-day session which are held in the odd numbered years and only fiscal related matters are germane during 30 day sessions which are held during even numbered years. Below are the bills that directly impact New Mexico State University and higher education.

NMSU Requested Legislation

NMSU requested legislation that dealt with [University Police Jurisdiction](#) (HB 233); [Sunset Extension of the Non Athletic Gross Receipts Deduction](#) (HB 249 / SB 94); two Inspection of Public Records Act modifications that dealt with [proprietary information](#) and [job applicants](#) (HB 267 and SB 93 respectively); and [Compliance Inspections for Food Safety Laws](#) (New Mexico Department of Agriculture – HB 305). All NMSU requested legislation passed the legislature except for the two bills related to IPRA. The Governor signed HB 249 (College Special Event Gross Receipts) and HB 305 (Compliance Inspections for Food Safety Laws) which was requested by New Mexico Department of Agriculture.

Other Legislation Directly Related to NMSU

1. HB 108/SB 103 (Transfer of College Credits)

- Modifies the post-secondary education articulation act in three ways:
 1. Requires the Higher Education Department (HED) and higher education institutions (HEI) to maintain the statewide common course numbering system and requires HEIs to accept commonly numbered transfer courses as equivalent;
 2. Removes the content area requirements of the current statewide general education core and decreases the minimum number of general education credits required; and
 3. Requires HED to facilitate the development of statewide meta-majors for undecided students.

2. HB 88/SB 197 (Loan Repayment for Certain Students)

- The House Education Committee Substitute for House Bill 88 converts the Minority Doctoral Assistance Loan for Service Program Act to the Minority Doctoral Loan Repayment Act. The bill provides for repayment of loans for “an individual who is a member of an ethnic minority or is a woman and who has successfully completed a doctoral degree-granting program at an eligible

institution in the field of engineering, physical or life science or mathematics or another academic discipline in which ethnic minorities or women are underrepresented.” The bill further requires the department to give preference to a recipient who has completed a postsecondary degree at an institution designated in Article XII, Section 11 of the Constitution of New Mexico.

3. SB 181 (Colleges as Tax Refund Intercept Claimants)

- HED has a statutory duty to begin the collection process on the loan. In response to an FY15 external audit finding, HED currently contracts with an external vendor to pursue defaulted loans; the contract expires June 1, 2020. HED will enhance collection efforts by offsetting the amount of debt owed against the defaulted participant’s state income tax refund. The tax refund of a borrower’s spouse may also be intercepted. The bill as amended by the House Taxation and Revenue committee establishes a priority of HED’s claims to ensure that child support and other existing claims against the tax refund continue to receive priority.

Lottery Related Legislation

A total of 10 lottery bills were introduced that deal with revenue enhancement, means testing, back loading, tuition decoupling, students with disabilities and gap year. Only 2 of the 10 bills that were introduced passed the legislature and SB 420 (Lottery Scholarship Grace Period) was enacted into law.

Most importantly, HB 237 (Liquor Tax to Lottery Scholarship Fund) failed to pass the legislature. HB 237, as amended by the House Taxation and Revenue Committee, extended the transfer sunset to FY20 but phased-out the transfer at from 39 percent in FY18 to 34 percent in FY18, to 28 percent in FY19 and 22 percent in FY20. Students are likely to receive 65% - 70% of the sector tuition average this upcoming academic year compared to the 90% they currently receive.

SB 420 (Lottery Scholarship Grace Period) that was requested by ASNMSU was signed by the Governor. SB 420 allows a 16-month grace period for a qualified student to enroll in a New Mexico higher education institution after graduating high school. ASNMSU also worked on a bill (SB276 – Lottery Scholarships Awards and Applications) which provides a higher lottery award as the student progresses towards graduation, however that bill failed to pass the legislature.

Other Higher Education Related Bills

SB 208 (School Advanced Placement Policy) passed the legislature and requires that institutions accept a score of three or higher on the College Board Advance Placement (AP) examination for course credit. This bill was requested by the College Board. The College Board provided information that indicated that all courses that are accepted are already at a three or higher with very few courses requiring a score higher than three. The bill also mandates that if an institution does not offer the corresponding course the institution shall provide an elective course. A related bill (SB 31 – Remove Certain Graduation Requirements) failed to pass the legislature. SB 31 removes the requirement that high school students must take an AP, honors, dual credit, or distance learning course to graduate from high school.
