- I. Call to Order** – Garrey Carruthers, Chancellor
Meeting called to order by Chancellor Carruthers at 8:30 a.m.
- II. Approval of Minutes of March 8, 2016, meeting**
- Move to approve minutes made and seconded. Committee unanimously in favor. Minutes approved as submitted.
- III. Old Business**
- A. Revision to Rule 4.30.30-Process to Determine Eligibility for Rehire Status (Lisa Warren/Andrew Pena)
- Discussion: Should notices be sent via certified mail?
 - Move to approve made and seconded. Committee unanimously in favor. Motion carries.
- B. New Regents Policy 5.00-Faculty and Academic Administration (Liz Ellis)
- Discussion: New version includes 2 revisions (areas B.10 & B.11) recommended by Faculty Senate. Changes requested by Dean Titus were accepted into latest version.
 - Move to approve made and seconded. Committee unanimously in favor. Motion carries.
- C. Revision to Regents Policy 1.05.96-Community College Faculty Council (Liz Ellis)
- Changes to how community college Faculty Council is constructed.
 - Revision has been reviewed and approved by Faculty Senate
 - Move to approve made and seconded. Committee unanimously in favor. Motion carries.
- IV. New Business**
- A. Revised Rule 2.80-University Communications; Use of NMSU Logo; Website(s) Guidelines (LWarren/Maureen Howard)
- Review of guidelines concerning use of NMSU logo
 - Rules regarding standards and use can be found at <https://brand.nmsu.edu>
 - University Communications is working on a separate area for personal, Aggie web pages. Goal for the new space will be for it to automatically “clean itself” at the end of each semester.
 - Questions or comments regarding NMSU logo or Aggie web pages to Maureen Howard no later than April 29, 2016.
- B. New Regents Policy 2.00-Risk Management, Safety and Security (Liz Ellis)
- All NMSU review groups have reviewed this policy and given their approval.

- NMSU Police Chief Stephen Lopez has requested a friendly amendment to the last sentence in paragraph A. Will read “Further, the administration is *directed* to provide services and programs to support this policy...”
- Motion made to accept with amendment.
- Move to accept made and seconded. Committee unanimously in favor. Amendment accepted.
- Motion made to go move policy 2.00 to 2nd reading.
- Move made and seconded. Committee unanimously in favor.
- Motion made to adopt policy.
- Move to adopt made and seconded. Committee unanimously in favor. Policy will move forward to Board of Regents.

C. New Regents Policy 9.80-Art, Archives and Other Collections (Liz Ellis)

- Policy does not change existing rule; moves policy out of Regents Policy Manual.
- EVPP is administrator for policy: Rules will be administered by others closer to the collection.
- Federal regulations supersede every rule.
- Policy primarily affects the Library, Art Department and Art Gallery and NMSU museums.

D. New Regents Policy 2.90-Information Data Security (Liz Ellis)

- Allows for appointment of Data Security Officer to keep Regents informed about status of NMSU data security.
- Policy will move to 2nd read.

E. Revised Regents Policy 2.90.20-Student Educational Records-FERPA Compliance (L Warren/Dacia Sedillo)

- Revision motivated by reformatting of the rule; nothing different included in the rule.
- Policy includes personal computer equipment that connects to NMSU
- Motion to entertain 1st and 2nd read.
- Move made and seconded. Committee unanimously in favor. Motion carries.

F. Revised Rule 2.90.20-Access To Student Educational Records-FERPA Compliance (L. Warren/Dacia Sedillo)

- Rule change will declassify Aggie ID’s
- US Dept. of Ed approved.
- Systems require a unique identifier; allows us to not inadvertently disclose data.
- Move to approve made and seconded. Committee unanimously in favor. Motion carries.

- NMSU can offer Mexican citizens in-state tuition at 1.5x
